



Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19 – Under 18 Waiver & Warning

COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact.

Queenscliff Netball Club Inc. (“the Club”) has put in place preventative measures to reduce the spread of COVID-19; however, the Club **cannot guarantee** that you and your family members will not become infected with COVID-19. Further, **attending the Club training and / or match day could increase** your risk and your family members’ risk of contracting COVID-19.

ACCEPTANCE

By accepting this Warning & Waiver and on behalf of my child(ren) I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren), myself and associated family members and Guardians may be exposed to or infected by COVID-19 by attending the Club and it’s associated activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. On behalf of my child(ren) and associated family members and Guardians, I understand that the risk of becoming exposed to or infected by COVID-19 at Club activities may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, volunteers, and program participants and their families.

On behalf of my child(ren) , family members and Guardians, I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren), myself or associated family members and Guardians (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that my child(ren), associated family members and Guardians may experience or incur in connection with my child(ren)’s attendance or participation in Club activities. On behalf of my child(ren), and on behalf of my associated family members and Guardians, I hereby release, covenant not to sue, discharge, and hold harmless the Club, its Volunteers, Executive Committee, Coaches, Umpires, Managers, Primary Carers, Mentors, Office Bearers and representatives, of and from the Claims,

including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Club, its Volunteers, Executive Committee, Coaches, Umpires, Managers, Primary Carers, Mentors, Office Bearers and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club program.

I can also **CONFIRM** that my child(ren) is(are) fit to participate in and attend netball activities and/or training and competition organised or managed by the Club and Manly Warringah Netball Association ("MWNA") and to the best of my knowledge do not pose a risk to other Club members in relation to the transmission of Covid-19.

I can confirm that my child(ren), associated family members and Guardians will follow the preventative measures set up by the Club for the protection of its members and wider community during all Club activities and in failing to willingly do so, accept that I may be stood down from the Club and its associated activities.

I am aware that I have a responsibility to the Club and the MWNA community for my child(ren), associated family members and Guardians not to attend or participate in any netball activity if they are feeling unwell and experiencing any Covid-19 associated symptoms such as a runny nose, cough, sore throat, fever, fatigue or shortness of breath.

I understand I am required to supply a Medical Certificate or COvid-19 Test Result to the Club when my child(ren) is(are) returning to participate in or attend QNC associated netball activities after sickness - **if requested** - and specifically if a Covid-19 test has been undertaken regardless of result.

I understand I have a responsibility to the Club and MWNA community to report a case of Covid-19 if confirmed within my family or close contacts group as soon as is practically possible and that myself and associated family members will not attend training or match play until cleared to do so by the Club or MWNA regardless of whether myself or family members show any symptoms of Covid-19.

If you cannot accept the Warning & Waiver you will not be able to participate in Club training or match play or other associated activities.
